Summary of BBLDWP Water-Conserving Plumbing Standards

Standards

Residential Plumbing Fixture	Maximum Flow Rate		Tips on determining your fixtures flow rate.
	Federal Standard	California Standard	
Toilets	1.6 GPF	1.28 GPF	For most toilet models, the date or flush volume is stamped under the tank lid or inside of the tank. For some toilet models, the flush volume is stamped on the toilet between the bowl and the tank. The use of displacement devices such as bottles or bricks, or the installation/ adjustment of flush valves or alternative flushing devices is prohibited.
	Gallons Per Flush= GPF		
Sink Faucets	2.2 GPM	1.2 GPM	The flow rate is typically stamped on the outside of the aerator, which is the tip of the faucet, in very small print.
	Gallons Per Minute = GPM		
Showerheads	2.5 GPM	2.0 GPM	The flow rate is typically stamped somewhere on the outside of the showerhead or on the face of the showerhead where the spray comes out, in very small print. Flow restrictors are not an acceptable substitute for low flow showerheads.
Urinals	1.0 GPM	0.5 GPM 0.125 Wall Mount	The flush volume is typically stamped on the outside of the urinal.

- Existing fixtures that meet the Federal Standard do not need to be replaced. However, we encourage our customers to strive to meet California and WaterSense standards to save water and money whenever possible.
- If a fixture does not currently meet federal standards, it must be replaced with a fixture that meets current California standards.
- Fixtures manufactured in the United States from 1994 to the present should meet current Federal standards.

Frequently Asked Questions

Are incentives available for installing low-flush toilets?	Yes, we offer a toilet rebate program, however, you must have an indoor water conservation survey before you remove any old toilets or you will not be eligible for a toilet rebate. Please call the DWP Conservation Department to schedule your appointment.
Are all buildings affected by this regulation?	Yes. All buildings, whether they are residential, commercial, or industrial, must have water-conserving plumbing fixtures in place within 90 days of change of service.
Who is responsible for retrofitting the property and filing a Certificate?	The buyer/transferee is responsible for ensuring that the property is in compliance and for filing a Water Conservation Certificate with the Department of Water within 90 days from change of service. The filing of a Water Conservation Certificate is not necessary if the property already has a certificate on file with the DWP.
Are there any exemptions?	<p>Yes, exemptions may be granted for the following situations:</p> <ul style="list-style-type: none"> • Local, state, and/or federally identified historical buildings with authentic plumbing fixtures • When a retrofit requires modifications to the plumbing system beneath a finished wall or surface • When the unique configuration of a building's drainage system or portions of the public sewer, or both, require a greater quantity of water to flush the system in a manner consistent with public health standards • If the property owner has declared bankruptcy or is in foreclosure. <p>Buyer/transferee or property owner must submit proof that such a condition exists prior to exemption</p>
Are there any property transfers that are not affected by this regulation?	<p>Yes, if a property changes ownership as a result of any of the following circumstances, it is not subject to the requirements:</p> <ul style="list-style-type: none"> • Court Order – including, but not limited to, an order by a probate court in the administration of an estate • The administration of a decedent's estate, guardianship, conservatorship, or trust* • One title co-owner of a real property transferring, selling, or exchanging with one or more other title co-owner(s) • A transfer without consideration, from one family member to another family member • A decree of dissolution of marriage, legal separation, or a property settlement agreement incidental to such a decree <p><i>*Note: The above-mentioned exemption is based on the property's acquisition through no monetary transaction; however, the property becomes subject to these requirements upon the sale thereof (i.e., monetary exchange of the property).</i></p>
